Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost (as specified above) bidding document in the Municipality Office's Rajaswa (revenue) account as specified above and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Sealed Bids or Electronic Bid must be submitted to **Bardibas Municipality Office, Bardibas, Mahottari** or before **12:00 PM on 2073-12-15**. Documents received after this deadline shall not be accepted.
5. Bids shall be opened in the presence of Bidders' representatives, who choose to attend at the address above **2:00 PM on 2073-12-15**. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to amount mentioned above **i.e. 2.5% of quoted amount (inclusive of VAT), which shall valid till 30 days beyond bid validity period.**
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
8. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.

Bidders who choose to submit the bid by E-Bidding System, must submit the original copies (Hard Copy) of all mandatory documents to Bardibas Municipality, Bardibas, Mahottari, within the five days of last date of bid submission. Non submission of the hard copy by the bidders within the specified time shall be considered as non responsive and may cause forfeiture of bid security.
11. The bidder must fulfill the Price schedule sheet in both word and figures in case of any difference of word and figure amount, the figure amount will be considered as bidders rate.
