

5. Sealed or electronic bids must be submitted to the office **Bardibas Municipality, Bardibas, Mahottari** by hand/courier or through PPMO website www.bolpatra.gov.np on or before **12:00 Noon on 2073/11/18**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2073/11/18** at the **Bardibas Municipality office, Bardibas, Mahottari**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 2,50,000.00** which shall be valid for 30 days beyond the validity period of the bid.
